Mayor's Message

The holiday season brought the Christmas Tree Lighting Parade to our village. Fire trucks and village trucks brightly decorated, Mr. and Mrs. Claus waving, and treats delivered by elves brought cheer to folks along the route on the sidewalks, front lawns, and at their door and windows. Thank you to the volunteers who made the event possible, and to the staff for bringing the season to our Main Street and village parks.

We received great news today; the village will receive a grant for \$137,500 from the Water Quality Improvement Project (WQIP) program to aid the village in funding the Department of Environmental Conservation mandate. The mandate requires the village to include a disinfection method for destroying disease-causing organisms in wastewater effluent in onsite wastewater treatment systems. The village will be installing an ultraviolet system for this process.

January meetings have been scheduled to plan the next phase of the Stormwater Project; this phase will be to locate and repair any damage to the system infrastructure. This project is being funded through the American Rescue Plan Act.

As 2021 draws to a close, we can look back on the accomplishments of our staff, the village committees, volunteers, and all those who help to make the village a community to be proud of. Folks come here to enjoy with us our parks and walking trails, our businesses (we have added five to Main Street), the ongoing restoration of the historic district, and the pride our community has.

Whether your holiday celebrations include traditions of generations, special new ones you have come to enjoy, or those you will experience for the first time; may your Christmas sparkle with moments of love, laughter, family, and friends. And may the year ahead be full of contentment, good health, and joy!

Notice of Permissive Referendum Relating to Cannabis Local Law Opting Out of **Retail Sales**

Public Notice: Permissive Referendum Local Law #5 of the year 2021

Please take notice that on December 8th, 2021, the Board of Trustees of the Village of Bergen adopted a local law opting out of allowing retail cannabis dispensaries and/or on-site cannabis consumption establishments from locating and operating within the boundaries of the Village of Bergen. Such local law is subject to permissive referendum.

Anyone wishing to protest against the adoption of such local law must file a petition with the Village Administrator within thirty (30) days of the adoption of the local law. See, Village Law §9-902.
