

Mayor's Message

I hope this newsletter finds you all well as we battle what old man winter has, to date, thrown at us. The above average snowfall and below normal temperatures are tough to deal with but cheer up as the first day of spring is 25 days away from my writing this newsletter.

I have contacted the DOT to complain about the potholes on Route 19 in the village. You may have seen on the news the shortage of road salt is impacting many municipalities. Currently our village is in very good shape with our supply of salt which we use to treat the streets for your safe travel. I remind you to refrain from parking on the streets and blocking side walks during snow events so our village crew can do their jobs in a safe and timely manner.

The entrance into Hickory Park off route 19 will now have a new name and number which is 1 Hickory Way. We needed an address for the park so we could submit paperwork to the state for a farmers' market which is slated to begin in July. This also furnishes the county 911 system with an address for the park.

We are awaiting information from vendors about the procurement of a new pavilion to replace the back pavilion. As stated in last month's newsletter, a park grant that the village received is being utilized in the funding of this project.

We await the delivery of electric equipment which will be installed in our substation upgrade. Site work is scheduled to begin this spring.

Tentative budgets for fiscal years 2025-2026 were accepted by the Village Board at the February 12th meeting. A public hearing is scheduled for April 9th at 6:15pm at the village office. The Board will vote on it later that evening.

In closing, a huge shoutout to our Village of Bergen Fire Department for all your service to the community. We are so blessed for your commitment and sacrifice. From the Desk of the Village Historian, Vicky Truax



Today's story is about the life of Mary Sardou. Mary (Marchioli) Sardou was born in Fairport in August of 1927. After graduating high school, Mary worked at the grocery store, A & P, as a cashier. That is where she met her husband, Pierson (Doc) Sardou. Doc, as we knew him, became a regular customer at the A & P. In 1949, they became engaged and married in May of 1950. They opened their first bowling center in 1951 in Rochester, but shortly after opening, the center was destroyed by fire. In 1954, the Sardou's learned of a roadhouse restaurant for sale in Bergen. They purchased the business from Hazel & Ernie Leyson who were the original owners since 1924. For one month Doc and Mary commuted from Fairport to Bergen. After that, they moved into the small apartment, which is now the back of the dining room. In 1953 and 1956 respectively, Tom and George were born, and the family became four. 1957 was a big year for the Rose Garden as Doc

and Mary added the eight bowling lanes and joined the BPAA. (Rochester Bowling Proprietors Association). They are still members today. The family moved upstairs above the bowling lanes to a much larger living space.

While the restaurant business continued to grow, Doc cooked, and Mary bartended. Mary was very friendly and personable to her patrons. She was well loved. Later in the evening, it wasn't uncommon to see both Mary and Doc behind the bar, taking care of business. Life was busy as the young couple now ran a restaurant and a bowling center. They became a popular couple in Bergen, and both bowled in leagues at their establishment. In 1957-58, the Sardou's bought the house next door (South) where the Leyson's had lived. In the early 60's, the Sardou's put in a gas station in the south parking lot next to the bowling center. The station didn't last long as Route 490 was built, and the traffic flow was not the same. In 1967, Mary's beloved husband "Doc" died of a heart attack. In the blink of an eye, life changed dramatically. At 13 years old, Tom, being the oldest son, stepped in and learned the ropes of the business. George, being a couple years younger, helped in the kitchen. Mary learned quickly how to operate the bowling lanes and to repair them. She would often go behind the machines to reset a pin or fix a malfunction. Finally in 1993, she stopped climbing in the bowling machines at the young age of 66. *Continued on page 2...*

Mary Sardou Continued from page 1... The name of the restaurant, "The Viking Valhalla" name, came about when the Sardou's remodeled the dining room with paneling. "Viking" was stamped on the back of the paneling. In 1994, Mary was named "Proprietor of the year", by the Rochester Bowling Proprietors Association and a story was printed in the Democrat & Chronicle. In 2007, George moved back to Bergen from California and Mary was very content in her life, as both of her sons were living close by. In 2017, she was the Grand Marshall in the Bergen Park Days parade. In 2024, the Rose Garden celebrated their 70th year in business and were presented the New York State Historic Business Preservation award with Mary at the helm, 65 of those 70 years.

Mary was a woman of integrity, and hard work never scared her. She was strikingly beautiful and fashionable, but down to earth. In June of 2019, Mary passed away. Bergen isn't the same. I was lucky to call her friend.





Department of Public Works

On-street parking on Lake Avenue is limited to 2 hours at all times and there is no overnight parking allowed.
