This resolution applies here in regards to the sign permits we are seeing tonight submitted by the Village of Bergen as part of the Streetscape portion of the Main Street Grant. The permit fees have been waived.

Resolution 12 of 2019

A RESOLUTION APPROVING BUILDING AND PLANNING FEE WAIVER FOR MAIN STREET GRANT PARTICIPANTS

WHEREAS, the Village of Bergen received the New York State Main Street Program Grant and desires to help Main Street Grant participants with costs associated with remodeling; **WHEREAS**, the Village believes that a temporary waiver of building permit fees will help to stimulate the revitalization goals of the historic downtown area;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF BERGEN AS FOLLOWS:

Certain building permit fees, set forth below, shall be waived for New York Main Street Grant participants for the period of time that Village of Bergen's New York Main Street Grant Program is active.

All signs will be made and installed by Sign Language. Following installation, the building owners will be responsible for maintenance and removal if the business moves.

Chairperson Vurraro will mail letters of approval to Labella Associates, the Village of Bergen, and the individual business owners by the end of this week.

Chairperson Vurraro read the letter from Ted Habgood of the Masonic Temple allowing Krista Lewis to present her request for a change of use of her salon on their behalf. Krista Lewis presented her Special Use Permit Application #02-2020 requesting a change of use from a Salon to a Laundromat and Microsalon at 12 South Lake Avenue.

Questions regarding use were discussed. Hours of operation from 7am to 10pm for the Laundromat as well as the Microsalon rooms. Gas dryers will be used. There will be six or seven washers and dryers to start with a maximum of ten to twelve as the business

grows. Venting will be done through powervents and a filter system will be placed further down the line for lint. Parking will be the same as for the current salon. Ken Kuter reminded the applicants that they will need to submit building permits before beginning work and to check the Department of State codes for this type of business on their website. Ken will check in the ADA compliance rules as the change of use may have implications for that.

A motion was made for the Village of Bergen Planning Board to hold a Public Hearing for #01-2020 application for special use permit for change of use at 12 South Lake Avenue at the next meeting on July 15, 2020 by Heather Painting and seconded by Kate Milliman. The motion carried by the following vote:
